Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Learning sequence

Connect: 'committee' covers several different things. Teach: STANDING committees are permanent and hold jurisdiction over a policy area; SELECT committees are created for a specific purpose, often investigation; JOINT committees draw from both chambers; CONFERENCE committees reconcile differing House and Senate versions of the same bill. Subcommittees divide the work further. Try: shared classification of supplied examples. Apply: students identify all four types with an example each. Reflect: the type tells you what it is for.

Check for understanding

Student identifies the four committee types with examples.

Learning sequence

Connect: which committee gets it matters enormously. Teach: bills are referred by subject to the committee holding jurisdiction, and because committees differ in composition and disposition, referral can decide a bill's fate before anyone has read it - which is why jurisdiction is fought over. Try: shared reasoning about supplied referral cases. Apply: students explain why referral matters and predict for three supplied bills. Reflect: an early procedural decision is often the substantive one.

Check for understanding

Student explains referral and why committee jurisdiction matters.

Learning sequence

Connect: the work itself. Teach: committees hold HEARINGS to take evidence and build a record, and MARKUP sessions to amend a bill line by line - which is where most of the actual drafting happens and where interest groups from Unit 7 exert most influence. A bill that emerges from markup may differ greatly from the one referred. Try: shared examination of supplied committee material. Apply: students explain both processes and their effects. Reflect: the floor vote is on the committee's bill, not the sponsor's.

Check for understanding

Student explains hearings and markup and their effect on legislation.

Learning sequence

Connect: the great majority never leave committee. Teach: committees are a filter, and inaction is the commonest outcome - no vote is required to kill a bill, only the absence of one. That makes committee chairs and the leadership who appoint them very powerful, and it means 'introduced' says almost nothing about a bill's prospects. Try: shared analysis of supplied figures. Apply: students explain the filter and what it implies about reading news of an introduced bill. Reflect: doing nothing is a decision here.

Check for understanding

Student explains the committee filter and its significance.

Learning sequence

Connect: the standard's verb is EXPLAIN THEIR ROLES IN POLICY-MAKING. Teach: the explanation covers the types, jurisdiction and referral, hearings and markup, and the filtering effect - showing that committees are where policy is made rather than merely reviewed. Try: shared drafting. Apply: students write and file the explanation. Reflect: next week follows a bill through all of it.

Check for understanding

Student explains committee types and their policy-making role.

THIS ENTRY IS UNITED STATES GOVERNMENT, which the course of study places at GRADE 12 as a REQUIRED HALF-CREDIT course paired with another half-credit course, Economics. Its social studies standards are organised by grade through the high school years -- Grade 9 World History and Geography, Grade 10 United States History I, Grade 11 United States History II, Grade 12 Government and Economics -- so study of Government at any earlier grade is an alternate sequence, which is what the workbook row is called. Forty-four codes across five topics: Foundations of American Government, Branches of Government, Key Institutions and Political Participation, Citizenship and Civic Responsibilities, and Local and State Government. Lettered sub-parts are full assessable statements and are registered as separate codes. TWO TRANSCRIPTION FACTS ABOUT THE SOURCE ARE DISCLOSED HERE RATHER THAN CORRECTED. First, the document prints NO 11a and labels TWO DIFFERENT sub-parts 11b -- one on how the Electoral College functions, one on reapportionment, redistricting and gerrymandering; both are reproduced, the second keyed 11b (2), because inventing an 11a would assert a correction the document does not make. Second, standard 1 ends without a full stop in the source, after Treatise on Tolerance (Voltaire, 1763); it is transcribed as printed. THIS GRADE 12 ENTRY IS THE ORDINARY PLACEMENT AND THE OTHER TWO ARE THE ALTERNATE SEQUENCES. The course of study puts United States Government in Grade 12, so this row -- not the Grade 10 or Grade 11 one -- is where the state actually files the course. The standard set is identical at all three grades because Alabama publishes ONE Government course; writing a different year against an identical set would invent a distinction the state does not make, so the three rows share a curriculum and each listing says which placement it is. THE HALF-CREDIT PAIRING IS SHARPEST ON THIS ROW rather than on the alternate ones: at Grade 12 the state pairs Government with Economics as two half-credit courses inside ONE year, so a Grade 12 department buying both rows in this series is buying 360 days of plan for
