Essential question	How do you solve a rehearsal problem without creating a bigger one?
Standards	Creating / Rehearse (1) -> TH:PR4b-HSP Alaska Arts Standards / Perform / Anchor Standard 4 - Select, analyze, and interpret artistic work for performance — b. Shape character choices using given circumstances in a drama/theatre work. Creating / Rehearse (3) -> TH:RE7a-HSP Alaska Arts Standards / Respond / Anchor Standard 7 - Perceive and analyze artistic work, including those from diverse cultural traditions — a. Respond to what is seen, felt, and heard in a drama/theatre work to develop criteria for artistic choices.

Measurable objectives

- Students will explore artistic solutions and make analytical choices in a devised or scripted drama or theatre work, working as part of a creative team.
- Students will utilize best practices and make strategic safe choices during the rehearsal process, working collaboratively.

- "I choose analytically rather than by preference."
- "My choices are safe and I can say why."

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.

Support area	This week's plan
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Rehearsal problems solved analytically with safe, stated choices.

Family communication

Ask your child what problem their rehearsal had to solve.

Learning sequence

Connect: Unit 2's interpretation. Teach: that rehearsal is mostly problem-solving - a moment that does not read, a transition that will not work, a space that will not hold the idea. Try: shared listing of the problems in a current scene. Apply: students name three problems precisely. Reflect: name the problem or you will solve the wrong one.

Check for understanding

Student names rehearsal problems precisely.

Differentiation in the moment

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Learning sequence

Connect: the problems. Teach: generating several artistic solutions before choosing - staging, pace, physical choice, technical element, cutting - and why the first solution is usually the most obvious rather than the best. Try: shared generation of four solutions to one problem. Apply: students generate solutions for their own problem. Reflect: you cannot choose analytically from one option.

Check for understanding

Student generates several solutions to one problem.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Learning sequence

Connect: solutions. Teach: what makes a choice ANALYTICAL - it is tested against the interpretation, the given circumstances and what the audience will actually perceive, rather than against what the team likes - and the discipline of trying before deciding. Try: shared testing of two solutions. Apply: students test and choose, recording the reason. Reflect: try it, then decide; the argument ends the moment somebody stands up.

Check for understanding

Student chooses a solution analytically and records why.

Learning sequence

Teach: that this week's standard says STRATEGIC SAFE CHOICES - safety as a design constraint considered when the choice is made, not a check afterwards - and the ordinary practices: a cleared and swept space, known exits, warm-up before demanding movement, nothing carried backwards, nothing done for the first time at full speed. Try: shared safety walkthrough of the actual space. Apply: students state the safe practice for their chosen solution. Reflect: a solution that is not safe is not a solution.

Check for understanding

Student states the safe practice governing a chosen solution.

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.

Learning sequence

Connect: the choices. Teach: recording the problem, the options, the analytical choice and the safety consideration as a rehearsal record the team shares - which is what makes 'working collaboratively' visible rather than assumed. Try: shared review of a model record. Apply: students complete the record. Reflect: the record is what the next rehearsal starts from.

Check for understanding

Student completes a collaborative rehearsal record.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Every code is taught and every strand carries at least one, but the correspondence is mechanical and this listing says so rather than implying care that was not taken.
