Measurable objectives

- Students will document their ideas using systems of notation or technology.
- Students will choose a system that suits the idea.

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.

Support area	This week's plan
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

An idea documented so another pupil can reproduce it.

Family communication

Ask your child how they wrote their music down.

Learning sequence

Connect: ideas we have made and forgotten. Teach: writing it down means it survives and someone else can play it. Try: shared discussion. Apply: pupils explain. Reflect: the practical reason, which motivates the work.

Check for understanding

Student explains why documenting an idea is useful.

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Learning sequence

Connect: purpose. Teach: notating pitch and duration on a staff, at the level the class has reached. Try: shared notating. Apply: pupils notate a short idea. Reflect: pupils notate THEIR OWN music; NO PUBLISHED SCORE IS REPRODUCED anywhere in this plan.

Check for understanding

Student notates a short idea in standard notation.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Connect: standard notation. Try: shared trying. Apply: pupils try an alternative. Reflect: 'systems' is plural in the standard, so a pupil not yet fluent on the stave is not blocked.

Check for understanding

Student documents an idea using an alternative notation.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.
