Measurable objectives

- Students will present basic information orally and in writing in the target language.

- "I prepare rather than improvise."

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.

Support area	This week's plan
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Basic information presented both orally and in writing.

Family communication

Ask your child what makes presenting different from conversation.

Focus	The distinction.

Learning sequence

Connect: Unit 1's exchanges. Teach: that presentational language is one-way - no partner to repair a misunderstanding, no questions to fill gaps - so it must be prepared and clear in a way conversation need not be. Try: shared comparison. Apply: pupils state the difference.

Check for understanding

Student explains why presentational language must be prepared.

is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Fictional Example — Customize and Verify Before School Submission.

Focus	Drafting.

Learning sequence

Connect: the distinction. Teach: building a short presentation from structures already held rather than reaching for language beyond Level I, which is what makes it deliverable. Try: shared drafting. Apply: pupils draft a short presentation. Reflect: staying within known language is the skill, not a limitation.

Check for understanding

Student drafts a presentation using only known structures.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Learning sequence

Connect: drafting. Teach: pace, volume and pausing for a listener who cannot ask - and that slower is almost always better for both speaker and audience. Try: shared rehearsal in pairs. Apply: pupils deliver to a partner or small group. Reflect: NO PUPIL PRESENTS ALONE TO THE CLASS UNLESS THEY CHOOSE TO; a small group, one-to-one or a private recording all meet the standard.

Check for understanding

Student delivers a prepared presentation at a workable pace.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Learning sequence

Connect: oral delivery. Teach: that the standard names WRITING as well, that written form allows revision the spoken cannot, and what changes - spelling, accents or marks the language requires, punctuation. Try: shared writing. Apply: pupils write their presentation. Reflect: the two modes are assessed together.

Check for understanding

Student writes a short presentation with correct written conventions.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

THE STANDARDS ASSUME BILINGUALISM RATHER THAN A NAMED LANGUAGE: standard A is "communicate in two or more languages, ONE OF WHICH IS ENGLISH", and NO LANGUAGE IS NAMED ANYWHERE IN THE DOCUMENT OR IN THIS PLAN. Six of the fourteen sub-points are about CULTURE rather than language; the plan teaches culture as comparison, NAMES NO CULTURE AS REQUIRED CONTENT, and never presents any culture as more or less advanced than another.
