Measurable objectives

- Students will develop models to illustrate reflection, refraction, interference and diffraction.

Success criteria (student-friendly)

- "I model each of the four behaviours."
- "I state the condition each requires."
- "I identify which behaviour explains a given observation."

- Water trays or springs
- Torches if available

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.

Support area	This week's plan
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Four behaviours modelled with their conditions stated.

Family communication

Ask your child why a straw looks bent in a glass of water.

Focus	Bouncing back.
Learning target	"I can model all four wave behaviours and say what each requires."
Vocabulary in use	reflection, refraction, interference, diffraction, boundary, superposition

Learning sequence

Connect: waves. Teach: reflection at a boundary and the relationship between the incoming and outgoing directions, modelled with a spring or a water tray. Try: shared modelling. Apply: students model reflection and record the relationship. Reflect: the wave did not stop; it changed direction.

Check for understanding

Student models reflection and states the direction relationship.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Focus	Bending on entry.
Learning target	"I can model all four wave behaviours and say what each requires."
Vocabulary in use	reflection, refraction, interference, diffraction, boundary, superposition

Learning sequence

Connect: reflection. Teach: refraction as a change of direction caused by a change of SPEED at a boundary, which is the part usually left out - the bending is a consequence, not the cause. Try: shared modelling. Apply: students model refraction and explain the cause. Reflect: it bends because it slows, and next week explains why it slows.

Check for understanding

Student explains refraction as a consequence of a speed change.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Focus	Waves meeting.
Learning target	"I can model all four wave behaviours and say what each requires."
Vocabulary in use	reflection, refraction, interference, diffraction, boundary, superposition

Learning sequence

Connect: waves in one medium. Teach: two waves overlapping and adding, with reinforcement and cancellation modelled on graph paper by adding displacements point by point. Try: shared addition of two waves. Apply: students add two waves and identify both effects. Reflect: cancellation is not destruction; move along and the waves continue.

Check for understanding

Student models interference by adding displacements.

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Focus	Spreading round.
Learning target	"I can model all four wave behaviours and say what each requires."
Vocabulary in use	reflection, refraction, interference, diffraction, boundary, superposition
Local date	_____

Learning sequence

Connect: boundaries. Teach: diffraction as spreading at a gap or edge, and that the amount depends on the gap size relative to the wavelength - which is why you hear round a corner but do not see round one. Try: shared modelling with a water tray or supplied diagrams. Apply: students model and explain the corner observation. Reflect: one relationship explains a difference between sound and light you have noticed all your life.

Check for understanding

Student explains diffraction differences using wavelength and gap size.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Learning sequence

Connect: four behaviours. Teach: identifying which behaviour explains each of several observations, including one that needs two. Try: shared identification for three. Apply: students identify the behaviour for five observations. Reflect: the four together explain nearly everything waves do at a boundary.

Check for understanding

Student identifies the behaviour explaining an observation.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.
