Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.

Support area	This week's plan
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Check: child names trusted adults and what makes them trustworthy.

Family communication

Help your child name five trusted adults they could go to.

Every Alaska health row in this series therefore carries the same twenty-six items, and the listing says so plainly so that nobody buys two of them expecting different standards. WHAT DIFFERS BETWEEN THE GRADES IS THE PLAN, NOT THE STANDARD. ONE SUB-POINT NEEDS SAYING OUT LOUD BEFORE PURCHASE: A.7 is "understand the physical and behavioral characteristics of human sexual development and maturity". That is a K-12 standard and it is registered here because it is in the document, but AT KINDERGARTEN THIS PLAN TEACHES NOTHING BEYOND NAMING BODY PARTS, PERSONAL BOUNDARIES AND WHO A CHILD CAN TELL, which is the age-appropriate part of it. NO LESSON IN THIS PRODUCT TEACHES SEXUAL CONTENT, and any instruction in this area is governed by your district's own policy and parental-notification requirements, which take precedence over anything written here. NOTHING IN THIS PRODUCT IS MEDICAL ADVICE. A.4 concerns recognising patterns of abuse; it is taught as who to tell and that it is never the child's fault, no child is asked about their own home, and disclosures follow your district's safeguarding process rather than anything in this plan.
