Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.

Support area	This week's plan
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Rehearsal skills named and one applied deliberately.

Family communication

Ask your child what makes a rehearsal a good one.

Learning sequence

Connect: Unit 2. Teach: is a claim about cause and effect supported by evidence, not a rehearsal routine to follow - and that the unit therefore has to establish what rehearsal skills are and how quality is measured before any conclusion is possible. Try: shared reading of the standard, clause by clause. Apply: students state what evidence such a conclusion would need. Reflect: this is the most demanding standard in the level.

Check for understanding

Student states what evidence this week's standard's conclusion requires.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Teacher reflection (fictional example)

Fictional Example — Customize and Verify Before School Submission.

Learning sequence

Connect: the standard. Teach: the actual skills - isolating the smallest problematic unit, repeating with a stated intent rather than repeating, slowing to a tempo where it is right, marking so the fix survives, listening across the ensemble, coming in prepared, and knowing when to move on - and that each is observable. Try: shared listing from a rehearsal segment. Apply: students name the skills used in one segment. Reflect: observable is what makes it evidence later.

Check for understanding

Student names rehearsal skills observed in a segment.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Teacher reflection (fictional example)

Fictional Example — Customize and Verify Before School Submission.

Learning sequence

Connect: the list. Teach: the difference between repeating a passage and repeating it with a stated intent and a way of knowing whether the intent was met - and why undirected repetition reinforces the error as reliably as the fix. Try: shared demonstration of both. Apply: students rehearse a passage with a stated intent and record the outcome. Reflect: say what you are fixing before you play it again.

Check for understanding

Student rehearses with a stated intent and records the outcome.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Learning sequence

Connect: intent. Teach: choosing the smallest unit that contains the problem, and pacing a rehearsal so the hard bars get the time - including the discipline of leaving something unfixed today on purpose. YOUR SCHOOL'S OWN POLICY GOVERNS REHEARSAL DURATION, VOLUME AND BREAKS, AND TAKES PRECEDENCE OVER ANY PACING SUGGESTED HERE. Try: shared planning of a fifteen-minute segment. Apply: students plan and run a short segment. Reflect: the plan is what stops a rehearsal drifting.

Check for understanding

Student plans and runs a paced rehearsal segment.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Fictional Example — Customize and Verify Before School Submission.

Connect: the skills. Teach: choosing one rehearsal skill and applying it consciously across a full rehearsal, which is how a skill becomes usable rather than known. Try: shared choice and run. Apply: students apply one skill deliberately and note what it changed. Reflect: next week these get measured.

Check for understanding

Student applies a rehearsal skill deliberately and reports its effect.
