Measurable objectives

- Students will analyze and interpret data to support claims regarding circular motion.

- "I explain why circular motion is accelerated motion."

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Day 41 — Accelerating Without Speeding Up

Week 9, Day 1 · Unit 3 · Standards: ARM 10.53.810(1)(m)

Focus	The conceptual hurdle.
Learning target	"I can analyse circular motion and identify the centripetal force."
Vocabulary in use	centripetal force, centripetal acceleration, angular velocity, period, radius, tangential velocity

Learning sequence

Connect: velocity is a vector. Teach: that changing DIRECTION changes velocity even at constant speed, so circular motion is accelerated motion, and that by Newton's second law an acceleration requires a resultant force - which must point toward the centre. Teach why this feels wrong: the sensation of being thrown outward is the body continuing straight while the vehicle turns. Try: shared reasoning. Apply: students explain the direction of the acceleration in two cases. Reflect: what would happen if the force vanished?

Check for understanding

Student explains why circular motion requires a centre-directed force.

Day 42 — What Provides the Force

Focus	Centripetal force is a role, not a source.
Learning target	"I can analyse circular motion and identify the centripetal force."

Learning sequence

Connect: a force toward the centre. Teach: THE POINT STUDENTS MOST OFTEN MISS - 'centripetal' names a ROLE rather than a kind of force, so in every case some ordinary force is playing it: friction, tension, gravity, a normal force - and that adding a separate 'centripetal force' to a free-body diagram double-counts. Teach the diagnostic question: what would have to stop for the object to fly off? Try: shared identification across four supplied cases. Apply: students identify the provider in three. Reflect: did you add an extra arrow?

Check for understanding

Student identifies which real force provides the centripetal force.

Week 9, Day 3 · Unit 3 · Standards: ARM 10.53.810(1)(m)

Focus	The relationship.
Learning target	"I can analyse circular motion and identify the centripetal force."
Vocabulary in use	centripetal force, centripetal acceleration, angular velocity, period, radius, tangential velocity

Learning sequence

Connect: a force requirement. Teach: how the required force depends on speed and radius - rising with the square of speed and falling with radius - and what that means practically: doubling speed quadruples the force needed, which is why a tighter, faster turn fails first. Teach the reasoning from the relationship rather than from a memorised formula. Try: shared computation. Apply: students compute the effect of doubling speed and of halving radius. Reflect: which change mattered more?

Check for understanding

Student predicts how required force changes with speed and radius.

Focus	A second description.
Learning target	"I can analyse circular motion and identify the centripetal force."
Vocabulary in use	centripetal force, centripetal acceleration, angular velocity, period, radius, tangential velocity

Learning sequence

Connect: linear description. Teach: angular velocity and period as an alternative and often simpler description of the same motion, and the relationship between angular and tangential quantities - noting that points at different radii on one rotating body share an angular velocity but not a speed, which is the key to the muscular unit next week. Try: shared conversion. Apply: students compute tangential speeds at two radii. Reflect: which point moves fastest, and why?

Check for understanding

Student relates angular velocity to tangential speed at different radii.

Learning sequence

TEACHER NOTE. APPARATUS AND PROCEDURE ARE YOUR DEPARTMENT'S DECISION UNDER ITS OWN RISK ASSESSMENT. Anything swung, spun or released carries risk that only your own policy can assess; A SUPPLIED DATA SET MEETS THIS DAY IN FULL. Connect: a predicted relationship. Teach: how to test a proportionality from data - vary one quantity, plot in a form that straightens the relationship, and check the gradient - which is the linearisation idea in a physics setting. Try: shared plotting. Apply: students test the speed dependence from supplied or measured data. Reflect: did the data support the square relationship?

Check for understanding

Student tests a proportionality in circular motion against data.

Montana Office of Public Instruction. Montana Science Content Standards (2016), codified at ARM 10.53 subchapter 8. Statements are transcribed from the MONTANA SCIENCE CONTENT STANDARDS, whose own cover reads "Adopted September 16, 2016 by the Montana Board of Public Education". THAT DOCUMENT PRINTS NO CODES. Each grade is a set of discipline headings -- physical science, life science, earth and space science -- followed by unnumbered bullets, so there is nothing in it that can be printed in a code column. The same standards are codified in the ADMINISTRATIVE RULES OF MONTANA, CHAPTER 10.53 SUBCHAPTER 8, one rule per grade, and the rule's structure is exactly the document's: a numbered subsection per discipline heading, a lettered item per bullet, same order and same count. THE ARM SUBSECTION IS REGISTERED AS THE CODE. This is an existing official citation rather than an invented identifier, and it is the citation a Montana reviewer can actually look up; the alternative would have been to ship science products with no codes at all. Bullets are separated in the PDF by a Symbol-font character in the Unicode Private Use Area rather than by a literal dot; splitting on the indent instead merges a whole discipline into one run, and splitting per line fragments every standard mid-sentence, so the glyph is what the transcription splits on and the item count is checked against the counts the document's headings imply. THIS STATE PUBLISHES NO SCIENCE COURSES AT ALL. It writes ONE RULE FOR THE WHOLE OF GRADES 9-12, ARM 10.53.810, holding sixty-one standards in three disciplines, so this product's two halves -- physics, and human anatomy and physiology -- are not two of the state's courses but a selection across two of its disciplines. THIS ROW REGISTERS TWENTY STANDARDS: fourteen from physical science and six from life science. BE AWARE OF WHAT THE ANATOMY HALF IS ANSWERABLE TO, because it is less than the unit list suggests: THIS STATE PUBLISHES NO ORGAN-BY-ORGAN STANDARDS. What it has is (2)(b), the organisational structure of interacting systems that provide specific functions within multicellular organisms, and (2)(c), feedback mechanisms that maintain homeostasis, and those two carry most of the twelve body-system weeks. The weeks are real biology and they are worth teaching; they are simply not each one a separate state standard, and this listing would rather say so

than imply otherwise. THE REPRODUCTIVE SYSTEM WEEK CARRIES A LEGAL NOTE: MCA 20-7-120 defines human sexuality instruction to include instruction on sexual anatomy and reproduction, and requires notice of five to fourteen school days, materials available for inspection, and a parental right to withdraw with the absence recorded as EXCUSED. Check the current text before teaching that unit.
