Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.

Support area	This week's plan
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Forms shown and compared on stated dimensions.

Family communication

Ask your child the difference between a social and a technical dance form.

Day 41 — Social and Technical

Week 9, Day 1 · Unit 3 · Standards: ARM 10.53.719(1)(b)(iv)

Focus	The distinction.
Learning target	"I can show examples of dance forms and examine what they share and how they differ."
Vocabulary in use	social dance, technical dance, rhythmic activity, form, structure, comparison

Learning sequence

Connect: Week 3. Teach: the distinction the standard draws - social forms danced with others for participation, technical forms with a defined vocabulary and standard of execution - with examples of each. NO FORM, TRADITION OR CULTURE IS RANKED, and no student is asked about their own background. Try: shared classification. Apply: students classify four forms and justify one. Reflect: the distinction is about purpose and structure, not about which is better.

Check for understanding

Student distinguishes social from technical dance forms.

Day 42 — Showing Examples

Week 9, Day 2 · Unit 3 · Standards: ARM 10.53.719(1)(b)(iv)

Focus	Level 1's verb.
Learning target	"I can show examples of dance forms and examine what they share and how they differ."

Learning sequence

Connect: the categories. Teach: SHOWING examples - performing short excerpts of each category in a group, everyone together, no solos, no watching. Try: shared performance. Apply: students show examples of both categories in a group. ADAPTED ROUTES: seated, marked, or hand-rhythm versions available without request. Reflect: showing is the standard's own verb, and a group shows perfectly well.

Check for understanding

Student shows examples of both dance categories.

Focus	Level 2 method.
Learning target	"I can show examples of dance forms and examine what they share and how they differ."
Vocabulary in use	social dance, technical dance, rhythmic activity, form, structure, comparison

Learning sequence

Connect: the examples. Teach: comparing forms on ONE dimension at a time - rhythm and metre, formation, contact, improvisation, purpose - which turns two descriptions into a comparison. Try: shared comparison on two dimensions. Apply: students compare two forms on three dimensions. Reflect: name the dimension or it is not a comparison.

Check for understanding

Student compares dance forms on a stated dimension.

Week 9, Day 4 · Unit 3 · Standards: ARM 10.53.719(1)(b)(iv)

Focus	The standard's own word order.
Learning target	"I can show examples of dance forms and examine what they share and how they differ."
Vocabulary in use	social dance, technical dance, rhythmic activity, form, structure, comparison

Learning sequence

Connect: dimensions. Teach: that the standard says SIMILARITIES and differences, in that order, and that starting from what forms share - beat, sequence, group coordination - makes the differences more visible and less exoticising. Try: shared listing of similarities. Apply: students list three similarities across four forms. Reflect: the similarities are why the skills transferred so quickly.

Check for understanding

Student identifies similarities across dance forms.

Focus	The standard's scope.

Learning sequence

Connect: dance. Teach: that the standard names rhythmic ACTIVITIES as well as dance - skipping, stepping, drumming patterns - and examining one against the same dimensions. Try: shared examination. Apply: students examine one rhythmic activity. Reflect: standard BK-2.4 is complete, and Unit 2's anchor with it.

Check for understanding

Student examines a rhythmic activity on stated dimensions.

Statements are transcribed from the MONTANA HEALTH ENHANCEMENT CONTENT STANDARDS (HEALTH AND PHYSICAL EDUCATION), grade-by-grade view, which carries the date 2016 in its own running head and is published by OPI as an accessibility-remediated 2018 file. THAT DOCUMENT PRINTS NO CODES: each grade is a single stem followed by one flat numbered list, and the numbering restarts at 1 in every grade and every subject. The standards are codified in the ADMINISTRATIVE RULES OF MONTANA, CHAPTER 10.53 SUBCHAPTER 7, which holds health and physical education as SEPARATE RULES -- health runs 10.53.702 to 10.53.709 and physical education 10.53.712 to 10.53.719, one rule per grade or grade band in each. THE ARM CITATION IS REGISTERED AS THE CODE, an existing official identifier rather than an invented one. THE RULE'S STRUCTURE IS NOT FLAT: subsection (1) holds lettered standards, each with roman-numbered sub-items, so the document's flat list is the rule's sub-items read end to end and the grouping has to be recovered. IT IS RECOVERED FROM THE RULE'S OWN PER-LETTER COUNTS RATHER THAN INFERRED FROM THE CONTENT, because inferring gives a different and entirely plausible wrong answer -- at kindergarten health, reading by subject suggests five interpersonal-communication items and six decision-making items where the rule has five and four, which would have shifted every later code into the wrong lettered standard. The item total is asserted against the rule's total before any code is written, so a mismatch stops the run rather than sliding the alignment silently. HEALTH ENHANCEMENT IS TWO SEPARATE RULES IN THIS STATE, and this row is the physical education half: ARM 10.53.719, twenty-six standards written once for the whole of grades 9 to 12. THIS ROW REGISTERS ALL TWENTY-SIX. The health half is ARM 10.53.709 and is a separate product. FOUR OF THE TWENTY-SIX CARRY AMERICAN INDIAN CONTENT INSIDE THE STANDARD ITSELF -- the historical and cultural roles of games, sports and dance, the comparison of dance forms, and planning and

taking part in a community physical activity event -- so Indian Education for All is part of the physical education requirement here and not an addition to it. THE STRAND LABELS IN THIS PLAN HAVE BEEN REWRITTEN FOR THIS STATE: the shared plan labels each strand with a code from another state's numbering, which would send you looking for a standard that does not exist here. The two levels are the plan's own structure -- the same strand at two levels of challenge -- and not a state scheme.
