Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.

Support area	This week's plan
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Examples classified with the dependence between categories explained.

Family communication

Ask your child whether a recipe is material culture or not.

Day 41 — Things and Not-Things

Week 9, Day 1 · Unit 3 · Standards: SS.G.9-12.4

Focus	The distinction.
Learning target	"I can differentiate material from nonmaterial culture and place folk customs correctly."

Learning sequence

Connect: the nine aspects. Teach: material culture as the objects a society makes and uses, nonmaterial as the beliefs, norms, customs and knowledge - with the boundary cases discussed rather than avoided. Try: shared classification of eight examples. Apply: students classify eight and justify two. Reflect: a recipe is nonmaterial; the dish is material; and neither exists without the other.

Check for understanding

Student classifies examples and justifies a boundary case.

Learning sequence

Connect: nonmaterial culture. Try: shared description of two. Apply: students describe two folk customs from sources. Reflect: 'folk' describes how something is transmitted, not how sophisticated it is.

Check for understanding

Student describes a folk custom accurately and neutrally.

Learning sequence

Connect: both categories. Teach: how an object encodes a belief and a belief requires objects, traced through two supplied examples. Try: shared tracing. Apply: students trace the dependence for two examples. Reflect: an object without its meaning is just a shape.

Check for understanding

Student explains the dependence between the two categories.

is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Learning sequence

Connect: the dependence. Teach: that material culture survives to be studied and nonmaterial culture largely does not, so our picture of the past is biased towards things - a real limitation on the evidence. Try: shared discussion. Apply: students explain one consequence of this bias. Reflect: what we know about a past culture is shaped by what happened to last.

Check for understanding

Student explains the evidential bias towards material culture.

Learning sequence

Connect: the relationship. Teach: inferring nonmaterial culture from a supplied object or image - what it implies about belief, technology and organisation - with the inference marked as an inference. Try: shared reading of one object. Apply: students read two objects and mark their inferences. Reflect: say which part you saw and which part you inferred.

Check for understanding

Student infers nonmaterial culture from an object, marking inferences.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Codes and statements are transcribed from the MONTANA CONTENT STANDARDS FOR SOCIAL STUDIES FOR K-12, which records on every page "Document Created April 5, 2021 | Effective date July 1, 2021" and states in its own text that "The following standards will go into effect on July 1, 2021". The document sets out its coding scheme explicitly as SUBJECT.STANDARD.GradeLevel SUBSTANDARD.sub-substandard, with SS social studies and the four content areas CG civics and government, E economics, G geography and H history. A STRUCTURAL FEATURE OF THIS DOCUMENT MUST BE UNDERSTOOD TO READ THE CODES CORRECTLY. Where a content area has SEVERAL standards at a grade, the area line is a stem and the standards are numbered beneath it. Where a content area has EXACTLY ONE standard at that grade, there is no numbered child: the standard is stated on the area line and ITS CODE ENDS AT THE GRADE, giving forms like SS.G.K and SS.H.K alongside SS.CG.K.1. The document signals the difference by writing "content standard is" rather than "content standards are", and that signal is what the transcription reads; a pattern that expected a final number would silently lose every single-standard area. THIS STATE NAMES NO SOCIAL STUDIES COURSES AT ALL. Its standards for grades 9 to 12 are ONE BAND of forty-three standards across four disciplines -- twelve civics and government, nine economics, eight geography and fourteen history -- and the state leaves it to the district to decide which courses carry them and in which year. So nothing here is a required course and nothing is a forbidden one. THIS ROW REGISTERS THIRTEEN OF THE FORTY-THREE, AND THAT IS THE WHOLE OF THE GEOGRAPHY DISCIPLINE -- all eight -- plus the five civics and economics standards the trade, globalisation and religion-and-politics weeks genuinely reach. The thirty it does not register are the rest of civics and government, economics and the whole of history, which the government, economics and history courses in this series carry; a geography year claiming those would be claiming their work. Note that SS.G.9-12.6 names MONTANA specifically, on the role of geography in

interactions and conflicts between cultures.
