Standards	Spotting Musical Ideas in a Piece -> Music Curriculum Standard 6, End of Grade 4 Music: Listen to, analyze, and describe music. — (a) identify simple music forms when presented aurally; (b) demonstrate perceptual skills by moving to, inquiring about, and describing aural examples of music from various styles representing diverse cultures; (c) use appropriate terminology in explaining music, music notation, music instruments and voices, and music performances; (d) identify the sounds of different instruments, including many orchestra and band instruments, and instruments from various cultures, as well as children's voices and male and female adult voices; (e) respond through purposeful movement to selected prominent features in a piece of music

Measurable objectives

- Students will discuss how creators use musical concepts in the music selected for performance.

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.

Support area	This week's plan
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Anecdotal: child identifies a musical concept in a listening example.

Family communication

Listen to a piece and spot something that repeats.

Proficiency is stated at the end of grades 4, 8 and 12, and the grade 8 and grade 12 lists are written as increments on the band below ("in addition to the above"), so a grade 12 course remains accountable for the earlier bands.
