Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.

Support area	This week's plan
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

A series planned with a stated theme and deliberate variation.

Family communication

Ask your child what holds their series together.

Learning sequence

TEACHER NOTE, AND SAY IT ALOUD BEFORE ANYTHING ELSE. IN THIS ROOM 'PERSONAL' MEANS THE STUDENT'S OWN CHOICE OF ENQUIRY AND NOTHING MORE. NO STUDENT IS REQUIRED TO MAKE WORK ABOUT THEMSELVES, THEIR FAMILY, THEIR BELIEFS, THEIR HERITAGE, THEIR DIFFICULTIES OR ANYTHING THEY WOULD RATHER NOT DISCLOSE, and rigorous work about an entirely impersonal subject meets the standard in full. A fourth-year art class is where students are most likely to be nudged toward confession, and that is the nudge this plan refuses. Connect: the standard. Teach: the reading above, and what a theme actually is -- a question or concern the works share, not a subject they depict. Try: shared distinction between subject and theme on supplied examples. Apply: students state a candidate theme. Reflect: is yours a theme or a subject?

Check for understanding

Student distinguishes theme from subject and states a candidate theme.

Focus	The design problem.

Learning sequence

Connect: a series must hang together and not repeat. Teach: what can hold a series together -- the question, the palette, the format, the process, the scale -- and that holding ONE of these constant while varying others is what produces a series rather than a set. Try: shared analysis of supplied series. Apply: students decide what will be constant in theirs. Reflect: what will vary?

Check for understanding

Student decides what is constant and what varies across a series.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Learning sequence

TEACHER NOTE: MEDIA ARE WHATEVER THE DEPARTMENT ALREADY HAS. No medium, brand or supplier is named or required, and a series made entirely in pencil on paper can meet the standard if the choices are justified. Teach: that a medium is a decision with consequences -- what it makes easy, what it makes hard, what it says before the image does -- so 'various' should mean deliberately chosen rather than merely several. Try: shared reasoning about supplied pairings. Apply: students justify their media choices. Reflect: what does your medium make hard?

Check for understanding

Student justifies media choices by their consequences.

Learning sequence

Connect: theme, constants, media. Teach: how to plan a series realistically -- how many, in what order, what each is testing, and what happens if one fails -- and that planning the ORDER matters because each should learn from the last. Try: shared planning. Apply: students plan their series. Reflect: is the number realistic?

Check for understanding

Student plans a series with order and purpose per piece.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

It carries no compact code, so a standard is cited by discipline, standard number and proficiency band, which is exactly how the framework identifies it. Proficiency is stated at the end of grades 4, 8 and 12, and the grade 8 and grade 12 lists are written as increments on the band below ("in addition to the above"), so a grade 12 course remains accountable for the earlier bands.
