Essential question	How do you write a sound so someone else can play it?
Standards	Notating Two-Chord Harmony -> Music Curriculum Standard 5, End of Grade 8 Music: Read and notate music. — (a) read whole, half, quarter, eighth, sixteenth, and dotted notes and rests in 2/4, 3/4, 4/4, 6/8, 3/8 and alla breve meter signatures; (b) read at sight simple melodies in both the treble and bass clefs; (c) identify and define standard notation symbols for pitch, rhythm, dynamics, tempo, articulation, and expression; (d) use standard notation to record their musical ideas and the musical ideas of others; (e) (for choral/instrumental students) sight-read accurately and expressively, music with a difficulty level of 2 on a scale of 1 to 6

Measurable objectives

- Students will document rhythmic ideas using standard notation or technology.
- Students will test their notation by having someone else read it.

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.

Support area	This week's plan
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

A notated rhythm another pupil can perform correctly.

Family communication

Ask your child to clap a rhythm they wrote down.

Focus	The purpose.
Learning target	"I can write down a rhythm so someone else can play it."
Vocabulary in use	notation, bar, beat

Learning sequence

Connect: pieces made by ear in Unit 1. Teach: that notation exists so music survives the person who made it and can be played by someone who never heard it. Try: shared discussion. Apply: pupils explain the purpose.

Check for understanding

Student explains what notation is for.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Fictional Example — Customize and Verify Before School Submission.

Focus	The symbols.
Learning target	"I can write down a rhythm so someone else can play it."
Vocabulary in use	notation, bar, beat

Learning sequence

Connect: purpose. Teach: the note and rest durations the class needs, and how they add up to a bar. Try: shared reading and clapping. Apply: pupils notate a four-beat rhythm. Reflect: taught as arithmetic pupils can check, which makes it self-correcting.

Check for understanding

Student notates a four-beat rhythm that adds up.

Differentiation in the moment

is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Focus	Verification.
Learning target	"I can write down a rhythm so someone else can play it."
Vocabulary in use	notation, bar, beat

Learning sequence

Connect: notating. Teach: the only real test of notation is handing it to someone who was not there. Try: shared exchange. Apply: pupils swap and perform each other's. Reflect: the exchange finds every error faster than checking your own.

Check for understanding

Student performs a rhythm from a classmate's notation.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Learning sequence

Connect: the test. Teach: correcting the notation rather than explaining it verbally - if it needed explaining, it was not notated. Try: shared correction. Apply: pupils revise. Reflect: same revision discipline as everywhere else in this course.

Check for understanding

Student corrects notation that was misread.

Connect: paper notation. Teach: that a recording, a grid or a notation app is a legitimate system under this standard, and when each is the better tool. Try: shared trial on whatever devices exist. Apply: pupils document one idea a second way. Reflect: NO SOFTWARE MUST BE BOUGHT; paper is a full route.

Check for understanding

Student documents an idea using a second system.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

It carries no compact code, so a standard is cited by discipline, standard number and proficiency band, which is exactly how the framework identifies it. Proficiency is stated at the end of grades 4, 8 and 12, and the grade 8 and grade 12 lists are written as increments on the band below ("in addition to the above"), so a grade 12 course remains accountable for the earlier bands. New Hampshire is a local-control state: district schools, public charter schools and private schools each adopt their own curriculum, not the Department of Education nor the State Board of Education.
