Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.

Support area	This week's plan
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

A visual document of a chosen place or object with a written description.

Family communication

Ask your child what they chose to document, if they want to share it.

Learning sequence

TEACHER NOTE: this standard invites pupils toward home and family. NO PUPIL IS ASKED TO REVEAL ANYTHING ABOUT THEIR HOME OR CIRCUMSTANCES. An object is as valid as a place, a place in school or the neighbourhood is as valid as one at home, and a teacher-supplied object is a full alternative for any pupil who prefers it. Work stays private unless the pupil chooses otherwise. Connect: looking closely. Teach: what makes something significant - memory, use, person, feeling. Try: shared discussion of general examples. Apply: pupils choose privately. Reflect: the choice belongs to the pupil.

Check for understanding

Student chooses a place or object and says it is theirs to choose.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Learning sequence

Connect: the choice. Teach: that documenting needs longer looking than pupils expect, and what to look for - shape, proportion, texture, detail, how light falls. Try: shared observation of a supplied object. Apply: pupils observe and note. Reflect: DRAWING SKILL IS NOT THE ASSESSMENT; accurate observation is.

Check for understanding

Student records three specific observed details.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Week 9, Day 3 · Unit 3 · Standards: Visual Arts Curriculum Standard 6, End of Grade 8

Focus	Deliberate choice.
Learning target	"I can visually document a place or object that matters to me."
Vocabulary in use	document, significance, detail

Learning sequence

Connect: observation. Teach: that where you look from changes what the document says - close, far, above, from the side. Try: shared trial of three viewpoints. Apply: pupils choose one and say why. Reflect: a choice made on purpose is what makes it art-making rather than copying.

Check for understanding

Student chooses a viewpoint and justifies it.

Differentiation in the moment

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Connect: viewpoint. Teach: building the visual document with the elements that carry significance emphasised. Try: shared work. Apply: pupils document. Reflect: VISUALLY DOCUMENT is the standard's phrase, so accuracy serves meaning.

Check for understanding

Student produces a visual document of their subject.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Proficiency is stated at the end of grades 4, 8 and 12, and the grade 8 and grade 12 lists are written as increments on the band below ("in addition to the above"), so a grade 12 course remains accountable for the earlier bands.
