Measurable objectives

- Students will dribble with dominant and non-dominant hand, foot or implement while changing direction.

Success criteria (student-friendly)

- "I use my non-dominant side."
- "I keep the object close."
- "I change direction under control."

- Cones or markers

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.

Support area	This week's plan
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Dribbling with both sides while changing direction.

Family communication

Ask your child which side is harder and why they practise it.

Learning sequence

Connect: sending. Teach: that control comes from keeping the object close and touching it often. Try: shared practice. Apply: pupils dribble in a small space. Reflect: standard PE.CS1.B1.5-6.1, PE.CS1.B1.5-6.2, PE.CS1.B2.5-6.1, PE.CS1.B2.5-6.2 says WHILE CHANGING DIRECTION. ADAPTATION: larger or slower ball, bigger space, walking pace.

Check for understanding

Student keeps the object close while moving.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Focus	The standard's requirement.

Learning sequence

Connect: control. Teach: that the non-dominant side is deliberately practised because it will be needed, and that it will feel bad first - which is expected, not failure. Try: shared practice. Apply: pupils dribble non-dominant. Reflect: standard PE.CS1.B1.5-6.1, PE.CS1.B1.5-6.2, PE.CS1.B2.5-6.1, PE.CS1.B2.5-6.2 says DOMINANT AND NON-DOMINANT.

Check for understanding

Student dribbles with the non-dominant side.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Learning sequence

Connect: both sides. Teach: the change-of-direction move and keeping the body between the object and a defender. Try: shared practice around markers. Apply: pupils change direction. Reflect: connects directly to Unit 4.

Check for understanding

Student changes direction while keeping control.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Learning sequence

Connect: direction. Teach: dribbling without watching the object, built up gradually so it does not simply fail. Try: shared practice with a visual cue to spot. Apply: pupils look up. Reflect: the skill that separates practice from play.

Check for understanding

Student dribbles while looking up.

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Reflect: standard PE.CS1.B1.5-6.1, PE.CS1.B1.5-6.2, PE.CS1.B2.5-6.1, PE.CS1.B2.5-6.2 recorded; where no implements exist, feet and hands meet the standard.

Check for understanding

Student dribbles with feet under control.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.
