Essential question	What can you do to a movement to make more dance?
Standards	Dance: Choreographic Devices and Intent -> DA:Cr2.1.6 Organize and develop artistic ideas and work. — a. Explore choreographic devices and dance structures to develop a dance study that supports an artistic intent. Explain the goal or purpose of the dance. b. Determine artistic criteria to choreograph a dance study that communicates personal or cultural meaning. Based on the criteria, evaluate why some movements are more or less effective than others.

- Students will explain how a dance study with a clear artistic intent uses a variety of choreographic devices.

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.

Support area	This week's plan
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Devices applied to a phrase with the effect explained.

Family communication

Ask your child what a choreographic device is.

Focus	The premise.
Learning target	"I can name and use choreographic devices to develop material."
Vocabulary in use	device, repetition, retrograde

Learning sequence

Connect: recorded material. Teach: that a short phrase becomes a whole dance through devices, so material shortage is never the real problem. Try: shared demonstration. Apply: pupils recall a phrase.

Check for understanding

Student recalls a phrase accurately for development.

Differentiation in the moment

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Teacher reflection (fictional example)

Fictional Example — Customize and Verify Before School Submission.

Most learners met the target. Two needed the visual cue repeated during guided practice; I will pre-teach with them tomorrow. The extension held attention longer than planned, so I shortened closure.

Focus	Three devices.
Learning target	"I can name and use choreographic devices to develop material."
Vocabulary in use	device, repetition, retrograde

Learning sequence

Connect: the premise. Teach: repeating, performing together, and performing in overlap - the three that transform group work most. Try: shared practice. Apply: pupils apply all three. Reflect: canon is the one Grade 6 groups find most rewarding and most difficult.

Check for understanding

Student performs a phrase in canon.

Differentiation in the moment

is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Teacher reflection (fictional example)

Fictional Example — Customize and Verify Before School Submission.

Most learners met the target. Two needed the visual cue repeated during guided practice; I will pre-teach with them tomorrow. The extension held attention longer than planned, so I shortened closure.

Focus	Three more.
Learning target	"I can name and use choreographic devices to develop material."
Vocabulary in use	device, repetition, retrograde

Learning sequence

Connect: the first three. Teach: reversing a phrase, changing its level, and changing its size. Try: shared practice. Apply: pupils apply two. Reflect: devices, not decoration - each changes the reading.

Check for understanding

Student transforms a phrase by size or level.

Differentiation in the moment

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Teacher reflection (fictional example)

Fictional Example — Customize and Verify Before School Submission.

Connect: devices. Teach: that a device is chosen because it serves what the dance is about, and that using every device is a common beginner error. Try: shared reasoning. Apply: pupils justify one choice.

Check for understanding

Student justifies a device choice by artistic intent.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.
