Unit 3: Shaping the Material · Month 3 · Quarter 1 · Semester 1 · Instructional Days 41–45

Essential question	How do choreographers turn a little material into a whole dance?
Standards	Choreographic Devices and Structures -> DA:Cr2.1.8 Cr — a. Collaborate to select and apply a variety of choreographic devices (e.g. retrograde, inversion) and dance structures (e.g. rondo, narrative, ABA) to choreograph an original dance study or dance with a clear artistic intent. Research how different professional choreographers approach their creative process and apply some of these ideas. Use genre-specific dance terminology to articulate the group process for making movement, sound and structural choices. b. Define and apply artistic criteria to choreograph a dance that communicates personal or cultural meaning. Discuss how the criteria clarify or intensify the meaning of the dance.

- Students will apply a variety of choreographic devices.

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.

Support area	This week's plan
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

A collaborative dance study using named devices with a stated intent.

Family communication

Ask your child which choreographic device they used and what it did.

Day 41 — Devices Are Transformations

Week 9, Day 1 · Unit 3 · Standards: DA:Cr2.1.8

Focus	The toolkit.
Learning target	"I can apply choreographic devices and structures with a partner or group."
Vocabulary in use	device, canon, retrograde

Learning sequence

Connect: Unit 2's material. Teach: a device transforms existing material - repetition, canon, unison, retrograde, augmentation, fragmentation - so material multiplies rather than having to be invented afresh. Try: shared application of two devices to one phrase. Apply: students apply two. Reflect: this is why Week 2's selection mattered.

Check for understanding

Student applies two named devices to existing material.

is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Day 42 — Structures That Hold a Dance

Week 9, Day 2 · Unit 3 · Standards: DA:Cr2.1.8

Focus	Structure.
Learning target	"I can apply choreographic devices and structures with a partner or group."
Vocabulary in use	device, canon, retrograde

Learning sequence

Connect: devices. Teach: dance structures as the shapes a whole piece takes - binary, ternary, theme and variation, narrative, accumulation - and that the structure is chosen for what it does to a viewer. Try: shared building in two structures. Apply: students choose a structure and say why. Reflect: devices are local, structures are global.

Check for understanding

Student chooses a dance structure and justifies it.

Closure and reflection

Day 43 — Collaborating Rather Than Dividing

Week 9, Day 3 · Unit 3 · Standards: DA:Cr2.1.8

Focus	The Level 3 shift.
Learning target	"I can apply choreographic devices and structures with a partner or group."
Vocabulary in use	device, canon, retrograde

Learning sequence

Connect: structure. Teach: that Level 3 says COLLABORATE AND APPLY, so the dance is made together rather than assembled from separate solos, and how that actually works - one person's material transformed by another, decisions tested by trying both. Try: shared collaborative building. Apply: groups build together. Reflect: 'you do yours and I'll do mine' is the failure mode of this standard.

Check for understanding

Student contributes to material that another student transforms.

Focus	Artistic intent.

Learning sequence

Connect: collaboration. Teach: that the standard says WITH A CLEAR ARTISTIC INTENT, so the group agrees what the dance is FOR before the devices multiply the material - otherwise the devices decide the piece. Try: shared intent-setting. Apply: groups write their intent. Reflect: the intent is what Week 10's criteria will be built from.

Check for understanding

Student's group states the artistic intent of their study.

Connect: intent. Teach: performing the collaborative study and identifying which devices and which structure were used where. Try: shared performance and identification. Apply: groups perform and identify. Reflect: Dance this week's standard assessed on the devices, the structure and the collaboration.

Check for understanding

Student identifies the devices and structure used in their group's study.

Differentiation in the moment
