### Measurable objectives

- Students will describe how the automobile, cinema, print media, and radio contributed to the rise in mass culture, economic growth, and expansion of the middle class.

### Learning sequence

Connect: supplied figures on car ownership, 1910 to 1929. Teach: mass production lowered the price until ownership reached ordinary households, and the consequences ran far beyond transport - road building, suburbs, the oil and rubber industries, instalment credit, and a change in what young people could do unsupervised. One technology, many second-order effects, which is how to think about all four this week. Try: shared mapping of the automobile's second-order effects. Apply: students build the effect map with evidence for each branch. Reflect: the second-order effects are usually the historically important ones.

### Check for understanding

Student maps the automobile's effects with evidence.

### Learning sequence

Connect: for the first time, millions saw and heard the same thing. Teach: cinema and radio created a genuinely national shared culture - the same stars, the same music, the same news, the same advertising - which is what MASS CULTURE means, and which had not been possible before. It also concentrated influence in whoever controlled the studios and networks. Try: shared analysis of supplied sources on cinema and radio reach. Apply: students explain how each contributed to a shared national culture. Reflect: shared culture and concentrated influence arrive together, and both are in the standard's word 'mass'.

### Check for understanding

Student explains how cinema and radio produced a national mass culture.

### Learning sequence

Connect: supplied magazine and newspaper circulation figures. Teach: national magazines and syndicated content carried the same material everywhere, and modern advertising developed alongside them - creating demand rather than only announcing supply, and making instalment credit respectable. That combination is what turned production capacity into a consumer economy. Try: shared analysis of supplied advertising facsimiles for technique. Apply: students analyse three facsimiles and explain the link between advertising and consumption. Reflect: this is Week 2's yellow-journalism skill applied to a different kind of persuasion.

### Check for understanding

Student analyses advertising technique and links it to consumption.

### Learning sequence

Connect: the sub-part names economic growth and expansion of the middle class alongside mass culture. Teach: rising productivity, new industries and consumer credit expanded the number of households with discretionary income - and the expansion was uneven, largely bypassing agriculture, much of the South, and Black Americans. The standard's claim is true and partial, and saying which parts is the analysis. Try: shared reading of supplied income and sector data. Apply: students describe the growth and state precisely who it reached and who it did not. Reflect: 'the country got richer' is a statement that needs a denominator.

### Check for understanding

Student describes economic growth and identifies who it did not reach.

### Learning sequence

Teach: evaluation needs criteria, and the plan supplies them - how many people were affected, how deeply, how durably, and whether the change outlasted the decade. Apply those to the technologies and the figures, and different defensible rankings will result. Try: shared evaluation of two supplied trends against the four criteria. Apply: students evaluate three trends and rank them with justification. Reflect: stating your criteria before you judge is what makes an evaluation arguable rather than an opinion.

### Check for understanding

Student evaluates trends against stated criteria and justifies a ranking.
