Measurable objectives

- Students will throw underhand and overhand using correct form in dynamic environments.
- Students will lead a moving receiver.

Success criteria (student-friendly)

- "I use correct form for both throws."
- "I hit a still target."
- "I lead a moving receiver."

- Assorted balls of different size and weight

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.

Support area	This week's plan
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Both throws performed with correct form to a moving receiver.

Family communication

Ask your child what a dynamic environment means.

Week 9, Day 1 · Unit 3 · Standards: 4.5.4, 4.5.5, 4.5.6, 4.5.7

Focus	Form first.
Learning target	"I can throw underhand and overhand with correct form when things are moving."
Vocabulary in use	underhand, overhand, dynamic

Learning sequence

Connect: Grade 4's throwing. Teach: the form for each throw - stance, opposition, release point, follow-through - and when each is the right choice. Try: shared practice at a still target. Apply: pupils throw both ways. Reflect: adaptation named - a lighter or larger ball, a shorter distance, or a rolled delivery.

Check for understanding

Student throws underhand and overhand with correct form.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Focus	The concept.

Learning sequence

Connect: still targets. Teach: dynamic means the target, the receiver, a defender or you are moving - the standard's new demand for this grade. Try: shared discussion and demonstration. Apply: pupils identify what is moving in three tasks. Reflect: this word governs Units 3 to 6.

Check for understanding

Student explains what makes a throwing task dynamic.

Focus	The thrower moves.
Learning target	"I can throw underhand and overhand with correct form when things are moving."
Vocabulary in use	underhand, overhand, dynamic

Learning sequence

Connect: dynamic. Teach: keeping form while jogging or after a stop, and why form breaks first in the feet. Try: shared practice. Apply: pupils throw on the move. Reflect: form is still the assessable part.

Check for understanding

Student keeps correct throwing form while moving.

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Learning sequence

Connect: throwing on the move. Teach: throwing to where a partner WILL be rather than where they are. Try: shared practice with a jogging partner. Apply: pupils lead a receiver. Reflect: this is the skill that makes a pass work in any game.

Check for understanding

Student throws ahead of a moving receiver.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Check for understanding

Student throws with correct form in a dynamic task.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.
