Standards	Dancing to Internal and External Rhythms -> 5.2PE PE — Demonstrate an understanding of the elements of dance and movement vocabulary when exploring, creating, and describing dance.
Learning target	"I can dance to internal and external rhythms and respond to changes in time."

Measurable objectives

- Students will dance to a variety of rhythms generated from internal and external sources.
- Students will perform phrases showing response to changes in time.

Success criteria (student-friendly)

- "I dance to an external rhythm."
- "I dance to an internal one."
- "I respond to a change in time."

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.

Support area	This week's plan
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Dancing to both rhythm sources with a response to a change in time.

Family communication

Ask your child what an internal rhythm is.

Week 9, Day 1 · Unit 3 · Standards: 5.2PE

Focus	External sources.
Learning target	"I can dance to internal and external rhythms and respond to changes in time."
Vocabulary in use	internal, external, pulse

Learning sequence

Connect: moving to sound. Teach: external rhythms - percussion, claps, snaps, stomps, and whatever sound source the school has, all of which the standard's own examples name. Try: shared practice. Apply: pupils dance to two external rhythms. Reflect: NO RECORDED MUSIC IS REQUIRED; the class makes the rhythm.

Check for understanding

Student dances accurately to an external rhythm.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Fictional Example — Customize and Verify Before School Submission.

Focus	Internal sources.
Learning target	"I can dance to internal and external rhythms and respond to changes in time."

Learning sequence

Connect: external. Teach: internal rhythms - breath and heartbeat, which the standard's examples name - and how a phrase driven by breath feels different from one driven by a drum. Try: shared practice. Apply: pupils dance to their own breath. Reflect: taught as a source of movement, not as a body measurement; NOTHING IS COUNTED OR RECORDED ABOUT ANY PUPIL'S BODY.

Check for understanding

Student dances to an internal rhythm.

Differentiation in the moment

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.

Connect: both sources. Teach: responding to a change in tempo or meter without stopping - the same recovery habit as any performing art. Try: shared practice with deliberate changes. Apply: pupils respond.

Check for understanding

Student adapts to a tempo change without stopping.

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Connect: responding. Teach: building a short phrase whose structure comes from a rhythm rather than from shapes. Try: shared building. Apply: pupils build. Reflect: material kept for Unit 4.

Student builds a phrase from a rhythmic source.

is ready for more	Invite the learner to demonstrate for a peer or add a second example.

Ohio Department of Education and Workforce. Ohio's Learning Standards for Fine Arts: Drama/Theatre (2024) + Ohio's Learning Standards for Fine Arts: Dance (2024). Ohio publishes one adopted fine arts document per discipline - Dance, Drama/Theatre, Media Arts, Music and Visual Art - and all five reuse the same code shape (scope.number + process), so the discipline is carried by the document rather than by the code. The four processes are Creating (CR), Performing/Presenting/Producing (PE), Responding (RE) and Connecting (CO). Ohio writes K-8 by grade and then switches to named proficiency levels - HSP, HSI, HSAC, HSAD - rather than to grades 9-12. Music additionally carries an ENSEMBLE ladder (ENN, ENI, ENS, ENAC, ENAD), which is what a band, choir or orchestra course sits on. Scope: scopes 5.
