Measurable objectives

- Students will obtain, evaluate and communicate evidence that explains how constructive and destructive processes shape Earth's surface.

- "I define both kinds of process."
- "I give evidence for each."

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.

Support area	This week's plan
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Evidence obtained, evaluated and communicated for both kinds of process.

Family communication

Ask your child for one thing that builds land and one that wears it away.

Connect: landscapes pupils know. Teach: that some processes add material and some remove it, and that most landscapes show both. Try: shared sorting. Apply: pupils classify six processes.

Check for understanding

Student classifies a process as constructive or destructive.

is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Fictional Example — Customize and Verify Before School Submission.

Connect: the distinction. Teach: finding evidence in a landform - what does this shape tell you happened here. Try: shared reading of landform images. Apply: pupils infer a process.

Check for understanding

Student infers a process from a landform.

is ready for more	Invite the learner to demonstrate for a peer or add a second example.

Learning sequence

Connect: obtaining. Teach: asking whether the evidence really supports the claim or only fits it, and considering an alternative explanation. Try: shared evaluation. Apply: pupils test two explanations. Reflect: fitting is not the same as supporting.

Check for understanding

Student evaluates whether evidence supports a claim.

Differentiation in the moment

is ready for more	Invite the learner to demonstrate for a peer or add a second example.

Connect: evidence. Teach: modelling deposition and erosion in a sand tray with water, recording what changes. Try: shared investigation. Apply: pupils run and record. Reflect: the model is evidence they generate themselves.

Check for understanding

Student records what a sand-and-water model shows.

is ready for more	Invite the learner to demonstrate for a peer or add a second example.
