Measurable objectives

- Students will obtain information about body systems from supplied sources.
- Students will evaluate sources and communicate findings.

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.

Support area	This week's plan
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Information obtained, a source evaluated, and findings communicated.

Family communication

Ask your child how they judged whether a source was reliable.

Learning sequence

TEACHER NOTE: ALL SOURCES ARE TEACHER-SUPPLIED. No pupil is sent to search the open internet in this plan, no account is created, and nothing is published outside the school. Connect: Weeks 7 and 8. Try: shared discussion. Apply: pupils state what each verb requires. Reflect: a poster that copies a source has done one of the three.

Learning sequence

Connect: the verbs. Teach: taking notes in your own words with the source recorded, then writing with the source closed - which makes copying nearly impossible. Try: shared practice. Apply: pupils take notes on one system. Reflect: this is a habit that protects the pupil.

Check for understanding

Student takes usable notes in their own words with the source recorded.

Connect: obtaining. Teach: who made a source, what they know, when it was made, and whether it agrees with another - applied to supplied sources of varying quality. Try: shared evaluation. Apply: pupils evaluate three. Reflect: a scientific claim is only as good as what stands behind it.

Check for understanding

Student evaluates a source with stated reasons.

Differentiation in the moment

is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Connect: evaluation. Teach: communicating a finding to a stated audience - what to include, what to leave, what a diagram carries better than words. Try: shared drafting. Apply: pupils draft for one audience. Reflect: pupils make their own diagrams; NO COPYRIGHTED IMAGE OR PUBLISHED MATERIAL IS REPRODUCED.

Check for understanding

Student communicates a finding appropriately for an audience.
