- Students will graph proportional relationships.

- "I choose and label a sensible scale."

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

A proportional relationship graphed and its rate read off.

Family communication

Ask your child what the steepness of their graph meant.

Focus	The step that decides everything.
Learning target	"I can graph a proportional relationship and read its rate from the graph."
Vocabulary in use	axis, scale, plot, unit rate, steepness, origin

Learning sequence

Connect: Week 8's tests. Teach: choosing axis scales from the data's range so the graph fills the space, and labelling both axes with quantity and unit - Week 7's precision applied. Try: shared scaling. Apply: pupils scale two axes for supplied data. Reflect: a badly scaled graph is unreadable however accurate the points.

Check for understanding

Student chooses and labels an appropriate scale.

is ready for more	Invite the learner to demonstrate for a peer or add a second example.

Focus	Accuracy.

Learning sequence

Connect: scaling. Teach: plotting accurately, and when joining points is meaningful - continuous quantities yes, counts of objects no. Try: shared plotting. Apply: pupils plot two relationships. Reflect: joining points that cannot exist between is a claim you did not mean to make.

Check for understanding

Student plots accurately and judges whether to join points.

is ready for more	Invite the learner to demonstrate for a peer or add a second example.

Learning sequence

Connect: plotting. Teach: reading the unit rate as the y-value at $x = 1$, and as the rise over any run - two routes to the same number. Try: shared reading. Apply: pupils read rates from three graphs. Reflect: the point at $x = 1$ is the fastest read, and it is why proportional graphs are useful.

Check for understanding

Student reads a unit rate from a graph.

Learning sequence

Connect: reading. Teach: comparing two proportional graphs by steepness and saying what the difference means IN THE SITUATION rather than in the maths. Try: shared comparison. Apply: pupils compare and interpret two. Reflect: steepness is a fact about the world, not the paper.

Check for understanding

Student interprets comparative steepness in context.
