Measurable objectives

- Students will explain how the desire for religious freedom served as a motivation for establishing colonies.
- Students will summarise efforts to limit religious freedom in the colonies.

Success criteria (student-friendly)

- "I explain the motive."
- "I give an example of a colony founded for it."
- "I describe a limit on it."

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.

Support area	This week's plan
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

The motive explained alongside an accurate account of its limits.

Family communication

Ask your child whether religious freedom meant freedom for everyone.

Focus	The motive.

Learning sequence

Connect: reasons for migration in Week 4. Teach: how persecution in Europe pushed groups to establish colonies where they could worship as they chose. Try: shared study. Apply: pupils explain one case.

Check for understanding

Student explains religious freedom as a founding motive.

Differentiation in the moment

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Teacher reflection (fictional example)

Fictional Example — Customize and Verify Before School Submission.

Most learners met the target. Two needed the visual cue repeated during guided practice; I will pre-teach with them tomorrow. The extension held attention longer than planned, so I shortened closure.

Focus	The complication.

Learning sequence

Connect: the motive. Teach: that several colonies founded by people fleeing persecution then restricted worship themselves, and that both facts belong in the account. Try: shared examination. Apply: pupils state both. Reflect: this week's standard exists precisely because the story does not stop at the motive.

Check for understanding

Student states both the motive and a restriction.

Connect: restrictions. Teach: what an established church was and how taxation and office-holding rules enforced conformity. Try: shared analysis. Apply: pupils describe a mechanism.

Check for understanding

Student explains one mechanism that limited religious freedom.

is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Connect: establishment. Teach: what happened to those who dissented, described accurately and without dramatisation. Try: shared study. Apply: pupils record. Reflect: NO ROLE-PLAY, NO ASSIGNED SIDES; sources are read and weighed.

Check for understanding

Student describes the treatment of dissenters from evidence.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection
