Essential question	What actually keeps a body well, and what is outside anybody's control?
Standards	Health, Activity and Eating Well -> 1.PA.8.3 Physical Activity — Explain the short-term and long-term benefits of moderate and vigorous physical activity (e.g., improving mood, self-esteem, attention, cognitive performance, cardiovascular health, strength, endurance, flexibility, and reducing risks for chronic diseases).

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.

Support area	This week's plan
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Ways discussed across activity, sleep and eating, with uncontrollable factors acknowledged.

Family communication

Ask your child why sleep counts as part of physical health.

Focus	The ground rules, stated first.
Learning target	"I can discuss ways that activity, sleep and eating patterns support health."

Learning sequence

SAFEGUARDING NOTE: this week's standard.PA.8.3 reads DISCUSS WAYS TO PREVENT OBESITY, and the classroom version of that topic - weighing pupils, calculating BMI, sorting foods into good and bad, setting weight targets - is a known contributor to disordered eating at exactly this age, not a neutral lesson. SO IN THIS WEEK NO PUPIL IS WEIGHED OR MEASURED, NO BMI IS CALCULATED, NO PUPIL'S BODY OR SIZE IS DISCUSSED OR COMPARED, NO FOOD IS CALLED GOOD OR BAD, AND NO BODY SIZE IS TREATED AS A FAILING OR A MORAL MATTER. If a pupil's relationship with food or with their body gives you concern, use your school's own route; do not handle it in the lesson. Connect: Unit 1's dimensions. Teach: the rules above, said aloud to the class. Try: shared restating. Apply: pupils record what this week is and is not about. Reflect: the standard is met by teaching what supports health, not by auditing bodies.

Check for understanding

Student states what this week does not do.

Day 42 — What Activity Does Inside a Body

Week 9, Day 2 · Unit 3 · Standards: 1.PA.8.3

Focus	Mechanism, not targets.
Learning target	"I can discuss ways that activity, sleep and eating patterns support health."
Vocabulary in use	activity, sleep, pattern

Learning sequence

Connect: the rules. Teach: what physical activity does - heart and lungs, strength, bone, sleep quality, mood - taught as mechanism, with NO target, no minimum anyone is measured against, and the point that movement someone will actually keep doing beats movement they will not. Try: shared listing from published health information. Apply: pupils record three effects. Reflect: mechanism is transferable; a number is not.

Check for understanding

Student names something activity does in the body.

Week 9, Day 3 · Unit 3 · Standards: 1.PA.8.3

Focus	The under-taught factor.
Learning target	"I can discuss ways that activity, sleep and eating patterns support health."
Vocabulary in use	activity, sleep, pattern

Learning sequence

Connect: activity. Teach: why sleep sits in a lesson about physical health at all - appetite regulation, concentration, mood, recovery - and that adolescent sleep timing shifts later by biology rather than by choice. Try: shared discussion. Apply: pupils explain why sleep belongs. Reflect: often the single most changeable factor at this age.

Check for understanding

Student explains why sleep belongs to physical health.

Week 9, Day 4 · Unit 3 · Standards: 1.PA.8.3

Focus	The honest framing.
Learning target	"I can discuss ways that activity, sleep and eating patterns support health."
Vocabulary in use	activity, sleep, pattern

Learning sequence

Connect: sleep. Teach: that health follows overall PATTERNS over time rather than any single food, that no food is good or bad, and that regular meals, variety and enough of them are what published health information actually says. Try: shared discussion of patterns in general terms. Apply: pupils record what a pattern means. Reflect: NO PUPIL DESCRIBES, RECORDS OR REPORTS WHAT THEY EAT, and nothing is collected.

Check for understanding

Student explains why patterns matter more than single foods.

Differentiation in the moment

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Learning sequence

Connect: the week. Teach: the factors outside a person's control - genetics, medical conditions, medication, money, what is available where someone lives, disability, sleep disruption - and why a lesson that ignores these teaches children to blame themselves and each other. Try: shared listing. Apply: pupils discuss ways health is supported AND name factors nobody chooses. Reflect: this week's standard.PA.8.3 recorded; the discussion is about health, and NOBODY'S BODY WAS THE SUBJECT.

Check for understanding

Student discusses supportive practices and names an uncontrollable factor.
