Essential question	What do I do when something is hard?
Standards	Sticking With It -> ELG.AL.1.C Approaches to Learning: Standard 1 — Takes care of materials. Examples: assists with clean-up. choose materials and put them away. • Store like-materials together and near area of intended use (For example: art materials stored together on art shelf located near tables, easels, and water). • Stacking tubs and boxes where children can access them. • Place heavier toys on bottom shelves. • Label storage containers with photos of real objects (For example: small blocks, figurines). • Label materials in two or more languages and include pictures (using home languages spoken that represent children in care first and then use other languages).

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.

Support area	This week's plan
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Child attempts a difficult task without immediate refusal.

Family communication

Let the child struggle a little before helping.

is ready for more	Invite the learner to demonstrate for a peer or add a second example.

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.
