Measurable objectives

- Students will compare and contrast perspectives across text types.
- Students will account for what each text type can and cannot do.

Success criteria (student-friendly)

- "I compare rather than describe in turn."
- "I account for what each text type can do."
- "I identify where the disagreement actually lies."

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.

Support area	This week's plan
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

A comparison of perspectives across at least three text types.

Family communication

Ask your child which two texts they compared and where they disagreed.

Focus	The range.

Learning sequence

Connect: reading across disciplines. Teach: comparing across kinds is harder and more valuable than comparing two novels - each kind can do things the others cannot. Try: shared listing of what each kind does well. Apply: students state one strength of each. Reflect: the range is required, not optional.

Check for understanding

Student states what each text type can do that the others cannot.

Differentiation in the moment

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Focus	Precision.
Learning target	"I can compare perspectives across fiction, nonfiction, digital and multimodal texts."
Vocabulary in use	perspective, multimodal, compare

Learning sequence

Connect: the kinds. Teach: that two texts rarely disagree about everything, and that locating the precise point - a fact, an emphasis, a value, a definition - is what turns a vague contrast into an analysis. Try: shared location on a described pair. Apply: students locate one. Reflect: most 'disagreements' turn out to be about a definition.

Check for understanding

Student locates the precise point on which two texts disagree.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Gather the group. Restate the learning target. Ask one learner to demonstrate. Name one specific thing the group did well, then preview tomorrow.

Focus	The discipline.

Learning sequence

Connect: the disagreement. Teach: that a comparison states a RELATION - more, less, whereas, both - and that a paragraph on each text is not one however good each paragraph is. Try: shared conversion. Apply: students write comparative statements.

Check for understanding

Student writes statements comparing rather than describing in turn.

Differentiation in the moment

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Learning sequence

Connect: comparison. Teach: that some of the difference between two texts comes from the FORM rather than the view - a documentary can show, an essay can argue, a poem can compress - so an honest comparison separates what the perspective contributed from what the medium did. Try: shared separation. Apply: students separate the two. Reflect: this is the subtlest move in the week.

Check for understanding

Student separates a perspective's contribution from the medium's.

Connect: separation. Teach: writing the comparison across at least three kinds with the disagreement located and the medium accounted for. Try: shared drafting. Apply: students write it. Reflect: this week's standard assessed; it returns in Week 36.

Check for understanding

Student writes a comparison of perspectives across three text types.
