Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.

Support area	This week's plan
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

An evaluation and comparison supported by evidence.

Family communication

Ask your child what they would change about their piece.

Learning sequence

TEACHER NOTE READ TO THE CLASS. This standard requires students to evaluate PEER work, so the rules are set now and hold all year. (1) Evaluation is of THE PIECE AND THE DECISIONS IN IT, never of the person, their talent or their playing. (2) Students evaluate their OWN work before anyone else's. (3) NO STUDENT'S WORK IS EVALUATED BY THE CLASS WITHOUT THEIR CONSENT, which may be withdrawn; written self-evaluation submitted to the teacher meets the standard in full, and that route is offered to everyone. (4) NO PIECE IS RANKED AGAINST ANOTHER STUDENT'S. Connect: finished pieces. Teach: the rules. Try: shared reading. Apply: students state them. Reflect: this is how a class can be honest without anyone getting hurt.

Student states the evaluation rules.

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.

Learning sequence

Connect: the rules. Teach: evaluating a piece against WHAT IT WAS TRYING TO DO rather than against what you would have written - which is the difference between evaluation and preference. Try: shared evaluation of a described piece. Apply: students evaluate their own piece against its stated intent. Reflect: judge it against its aim, or you are just describing your taste.

Check for understanding

Student evaluates a piece against its stated aim.

Differentiation in the moment

needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.

Learning sequence

Connect: evaluation. Teach: comparing two created works on named dimensions - structure, use of the forces, effectiveness of the ending - rather than deciding which is better overall. Try: shared comparison. Apply: students compare two pieces on three dimensions. Reflect: name the dimension and the comparison becomes useful.

Check for understanding

Student compares two created works on stated dimensions.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection

Focus	The full-credit clause.
Learning target	"I can evaluate and compare created work, mine and other people's."

Learning sequence

Connect: comparison. Teach: that the full-credit standard adds 'in a variety of genres and styles', which makes comparison harder because the criteria differ by style - and that acknowledging this is part of the answer. Try: shared discussion of criteria that do not transfer. Apply: students compare across styles and note where criteria failed. Reflect: judging one style by another's rules is the classic error.

Check for understanding

Student compares work across styles and identifies criteria limits.

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Closure and reflection
