Measurable objectives

- Students will demonstrate movements inspired by different stimuli and identify their sources.
- Students will name the stimulus that prompted their movement.

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.

Support area	This week's plan
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

Anecdotal: child names the source of their movement response.

Family communication

Move to a sound and say what you were responding to.

South Dakota writes its fine arts standards by grade only through grade five, and only for dance, theatre and visual arts. Music is written entirely in grade bands (K-2, 3-5, 6-8), every discipline uses a single 6-8 band above grade five, and high school is written by proficiency level - novice, intermediate, proficient and accomplished - rather than by grade. The band or level cited on this row is a suggested entry point for a typical class at this grade, chosen by this planner; it is not the state assigning levels to grades.
