### Learning sequence

Connect: 'committee' covers several different things. Teach: STANDING committees are permanent and hold jurisdiction over a policy area; SELECT committees are created for a specific purpose, often investigation; JOINT committees draw from both chambers; CONFERENCE committees reconcile differing House and Senate versions of the same bill. Subcommittees divide the work further. Try: shared classification of supplied examples. Apply: students identify all four types with an example each. Reflect: the type tells you what it is for.

### Check for understanding

Student identifies the four committee types with examples.

### Learning sequence

Connect: which committee gets it matters enormously. Teach: bills are referred by subject to the committee holding jurisdiction, and because committees differ in composition and disposition, referral can decide a bill's fate before anyone has read it - which is why jurisdiction is fought over. Try: shared reasoning about supplied referral cases. Apply: students explain why referral matters and predict for three supplied bills. Reflect: an early procedural decision is often the substantive one.

### Check for understanding

Student explains referral and why committee jurisdiction matters.

### Learning sequence

Connect: the work itself. Teach: committees hold HEARINGS to take evidence and build a record, and MARKUP sessions to amend a bill line by line - which is where most of the actual drafting happens and where interest groups from Unit 7 exert most influence. A bill that emerges from markup may differ greatly from the one referred. Try: shared examination of supplied committee material. Apply: students explain both processes and their effects. Reflect: the floor vote is on the committee's bill, not the sponsor's.

Student explains hearings and markup and their effect on legislation.

### Learning sequence

Connect: the great majority never leave committee. Teach: committees are a filter, and inaction is the commonest outcome - no vote is required to kill a bill, only the absence of one. That makes committee chairs and the leadership who appoint them very powerful, and it means 'introduced' says almost nothing about a bill's prospects. Try: shared analysis of supplied figures. Apply: students explain the filter and what it implies about reading news of an introduced bill. Reflect: doing nothing is a decision here.

### Check for understanding

Student explains the committee filter and its significance.

### Learning sequence

Teach: the explanation covers the types, jurisdiction and referral, hearings and markup, and the filtering effect - showing that committees are where policy is made rather than merely reviewed. Try: shared drafting. Apply: students write and file the explanation. Reflect: next week follows a bill through all of it.
