Measurable objectives

- Students will design and iteratively develop computational artifacts for practical intent, personal expression, or to address a societal issue by using current events.

Success criteria (student-friendly)

- "I state the artefact's purpose and audience."
- "I design before building."

Differentiation and supports

Support area	This week's plan
Special education / IEP	Reduce group size; pair visual cue cards with all verbal directions; allow gesture or picture response in place of speech; pre-teach the week's target in a 1:1 warm-up.
Section 504	Provide the child's documented accommodations throughout; permit movement breaks and alternative seating at any point in the sequence.
Multilingual learners	Introduce each vocabulary word with an object or image; accept home-language responses; send the vocabulary list home where a translation is available; pair with a peer who shares the home language.
Advanced / extension	Ask the learner to teach the skill to a peer, extend the task, or record a demonstration for the class reference wall.

Support area	This week's plan
Intervention / reteach	Reteach the target in a short small group using the same materials; split the day's check for understanding into two smaller steps.
Enrichment	Extend into an open-ended centre or project connected to the essential question.

Assessment and evidence

An artefact designed with a stated purpose and a first increment built.

Family communication

Ask your child what they are building and who it is for.

Focus	Choosing.
Learning target	"I can design and iteratively develop an artefact with a stated purpose."

Learning sequence

All three are equal routes and students choose. WHERE A STUDENT CHOOSES THE SOCIETAL ROUTE, the topic is theirs and NO STUDENT IS REQUIRED TO WORK ON ANYTHING PERSONAL, DISTRESSING OR POLITICAL; a practical or expressive artefact meets the standard identically, and that alternative is announced to the whole class. Connect: algorithms. Teach: the three purposes and what each implies. Try: shared discussion. Apply: students choose a purpose. Reflect: the purpose decides everything downstream.

Check for understanding

Student chooses and states an artefact's purpose.

Differentiation in the moment

If the learner...	Then...
needs more support	Model the step again with guided support, then fade to a gesture cue.
is ready for more	Invite the learner to demonstrate for a peer or add a second example.
is dysregulated	Pause instruction, move to co-regulation, and return to the target later.

Focus	Audience.

Learning sequence

Connect: purpose. Teach: naming the user, and that 'anyone' produces something for nobody - which is the same lesson every design subject teaches. Try: shared naming. Apply: students name their user and what that user needs. Reflect: one named user beats an imagined crowd.

Check for understanding

Student names a user and their needs.

Focus	The standard's first verb.

Learning sequence

Connect: audience. Teach: designing on paper first - what it does, its parts from Unit 1's decomposition, the algorithms from Unit 2, and what it will NOT do - and that scoping out is the decision that makes a project finishable. Try: shared design. Apply: students design their artefact on paper. UNPLUGGED ROUTE: the design is a full deliverable in its own right. Reflect: what you cut is what lets you finish.

Check for understanding

Student produces a paper design for an artefact.

is ready for more	Invite the learner to demonstrate for a peer or add a second example.

Focus	Iteration.

Learning sequence

Connect: design. Teach: ITERATIVELY DEVELOP as the standard words it - build the smallest version that does something real, get it working, then extend - rather than building all the parts and joining them at the end. Try: shared identification of a minimal first version. Apply: students define and begin their first increment. Reflect: something small that runs beats something large that does not.

Check for understanding

Student defines and begins a minimal first increment.

is ready for more	Invite the learner to demonstrate for a peer or add a second example.

Focus	Execution.

Learning sequence

Connect: the increment. Teach: building it, with the paper design beside the work. Try: shared session. Apply: students complete a working first increment. WHERE THERE ARE NO MACHINES, the increment is a fully specified traced design. Reflect: you have something that works, in week nine.

Check for understanding

Student completes a working first increment.
